APPLICATIONS

Tarmac GGBS in combination with Portland Cement or Portland Limestone Cement is used in a wide range of construction applications, including but not limited to, ready-mixed concrete, sprayed concrete, precast concrete, concrete products, mortar, grout, render and screed.

When used in combination with cement, Tarmac GGBS offers the following benefits, reduced risk of early-age cracking in large concrete pours, improved durability against sulfate attack & aggressive ground conditions, chloride ingress, and alkali silica reaction.

Tarmac GGBS is compatible with Portland cement and Portland Limestone Cement and chemical admixtures. Trial mixes are recommended to determine the optimum mix proportions.

Tarmac GGBS should always be used in accordance with the relevant product application standard.

The use of Tarmac GGBS to replace cement, reduces the embodied CO₂ of products
